2. The Commission has decided to extend the concession sought by the party under paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968. Accordingly, the candidate set up by " **Lok Janshakti Party**" shall be allotted the symbol '**Bungalow**' in the states mentioned in the table given in Para 1 above. The party is recognized state party in the state of Bihar and hence is entitled to exclusive allotment of its reserved symbol "Bungalow", to its candidate being set up in this state.

The Returning Officers may be informed that the candidates set up by " **Lok Janshakti Party** " in the aforesaid Constituencies are eligible for the allotment of the symbol '**Bungalow**' under paragraph 10 of the Symbols Order, 1968 subject to strict fulfillment of each of the provisions of paragraph 13 thereof.
