PROCEDURE FOLLOWED IN DECISION-MAKING PROCESS

[Section 4(1)(b)(iii)]

1. ELIGIBILITY FOR REGISTRATION IN THE ELECTORAL ROLL

Every person shall be entitled to be registered in the Electoral Roll for the Assembly Constituency of his/her residence subject to following conditions:

- a. is a citizen of India
- b. is not less than eighteen years of age on the qualifying date,
- c. is ordinarily resident in that constituency
- d. is not of unsound mind and stands so declared by a competent court and
- e. and is not for the time being disqualified from voting under the provision of any law relating to corrupt practices and other offences in connection with elections.

2. INCLUSION OF NAME IN THE ELECTORAL ROLL:

- An eligible citizen can apply in **Form No-6** at VREC of concerned Assembly Constituency on any working day for inclusion of name in the Electoral Roll for the Assembly Constituency of his/her residence. The applicant can also submit his/her application in form no. 6 online at the website of CEO Delhi i.e. www.ceodelhi.nic.in. The updating of Electoral Roll is a continuous process except for the period prescribed by Election Commission of India during the process of Election to Assembly/Parliamentary Constituency or during the period of Special Summary/Intensive Revision of Electoral Roll.

- When a person has migrated from one place to another either within the constituency or outside the constituency, he/she must indicate in his/her application the address of the previous residence so that his/her name could be deleted from the Electoral Roll of previous residence.

- No person shall be entitled to be registered in the electoral roll of more than one constituency.

- No person shall be entitled to be registered in the electoral roll for any constituency more than once.

- Any person who furnishes false information will be prosecuted under the provisions of the presentation of the People Act, 1950, which prescribes imprisonment and/or fine upto one year for such offences.

2(a) . A new section 20(A) has been added in the representation of the people Act 1950 after Section 20 , by the Representation of the people (Amendment) Act 2010. This new section provides that every citizen of India(a) whose name is not included in the electoral roll ,and (b) who has not acquired the citizenship of any other country ,and (c) who is absenting from his place of ordinary residence in India owing to is employment, education or otherwise outside India(Whether temporarily or not) shall be entitled to have his name registered in the electoral roll in the constituency in which his place of residence in India as mentioned in his Passport is located .

The Overseas Elector can apply for registration in Electoral Roll in Form 6A.

3. DELETION OF NAME FROM THE ELECTORAL ROLL:

The citizens may apply to the concerned Electoral Registration Officer in Form No.7 for deletion of name of an elector from the Electoral Roll on account of shifting of residence, death or any other reason.

4. APPEAL AGAINST THE DECISION / ORDER OF ELECTORAL REGISTRATION OFFICER WITH REGARD TO DISPOSAL OF CLAIMS & OBJECTION I.E. FORM-6, 6A, 7, 8, 8A & SUO-MOTO DELETIONS OF NAMES.

I. (A) During continuous updation of Electoral Roll: - If an applicant is not satisfied with the decision/order of Registration Authority rejecting or allowing an application u/s 22 or section 23 of RP Act, 1950, he or she can file an appeal to the concerned District Election Officer/District Magistrate (Appellate Authority u/s 24 of RP Act, 1950) within 15 days from the date of such order, the appeal should be in the form of a memorandum signed by the appellant and accompanied by a copy of the order appealed from and with a fees of five rupees.

(B) During summary revision of Electoral Roll: -An Appeal shall lie from any decision of the Electoral Registration Officer under rule 20, 21 and 21A to the appellate officer i.e. District Election Officer/District Magistrate:

Provided that an appeal shall not lie where the person desiring to appeal has not availed himself of his right to be heard by, or to make representation to, the Electoral Registration Officer on the matter which is the subject of appeal (Rule 23 & Registration of Electors Rules, 1960)

Every appeal shall be: -

- (a) In the form of a memorandum signed by the appellant, and
- (b) Presented to the appellate officer within a period of 15 days from the date of announcement of the decision or sent to that officer by registered post so as to reach him within that period.

II. Appeal against the decision / order of Appellate Officer:

An Appeal from any order of the appellate authority i.e. District Election Officer/District Magistrate shall lie to the Chief Electoral Officer, Delhi u/s 24(b) of RP Act, 1950. Every appeal u/s 24 shall be: -

- (a) In the form of a memorandum signed by the appellant;
- (b) Accompanied by a copy of the order appealed from and fees of five rupees to be—
 - (i) Paid by means of non-judicial stamps or
 - (ii) Deposited in a Govt. treasury or the Reserve Bank of India in favor of the Chief Electoral Officer, Delhi
 - (iii) Presented to the Chief Electoral Officer within a period of 15 days from the date of the order appealed from or sent by registered post so as to reach him within that period.

5. MODIFICATION OF ANY EXISTING ENTRY IN THE ELECTORAL ROLL:

The Citizen may apply in Form No.8 for modification of any existing entry in the Electoral Roll in respect of any wrong particular about him/her.

6. TRANSPOSITION OF NAME IN THE SAME ASSEMBLY CONSTITUENCY:

In case, any elector has shifted his residence within the boundary of same Assembly Constituency, he or she may apply in form No.8A for the transposition of his/her name in the Electoral Roll of his/her existing residential address

7. OTHER IMPORTANT INFORMATION

All above Application forms, during the normal period under section 22 or 23 of the Representation of People Act, 1950, read with rule 26 of Registration of Electors Rules, 1960, should be made **in duplicate**. However, during the period of filing claims and objections under Annual Revision exercise, only one

copy of application should be made. The office of the Electoral Registration officer, after receiving of any application mentioned above, will issue a receipt to the applicant. Thereafter, the application will be posted at the Notice board at the office of Electoral Registration Officer together with a notice inviting objections, if any to the inclusion of the applicant's name within a period of 7 days from the date of such posting. Every objection to the inclusion of a name should be submitted in Form-7 only by a person whose name is already included in the Electoral Roll. An application for correction of particular of entries in a roll can be submitted in form-8 only by the person to whom that entry relates. Thereafter, the electoral Registration Officer would take necessary action on the application for verification of the contents through field visit and/or through documents presented before him and pass appropriate orders on the application.

(i) ELECTOR'S PHOTO IDENTITY CARD (EPIC):

After the inclusion of name in the Electoral Roll of the concerned Assembly Constituency, the elector will be eligible for issue of Photo Identity Card. For the first time, provided other formalities are completed, the Card will be issued Free of cost. For issue of Identity Card, in case of loss or mutilated, the duplicate card can be obtained on furnishing declaration in the prescribed Performa and deposit of Rs. 25/-.

(ii) ISSUE OF CERTIFIED COPIES OF ENTRY IN THE ELECTORAL ROLL & PERMISSION FOR INSPECTION OF ENTRIES IN ELECTORAL ROLL

A certificate of an entry of the name of person/persons in the current Electoral Roll will be issued on payment of fee in the form of Court Fee stamp, as prescribed below. Inspection of a particular entry/entries in the Electoral Roll for a specific year will be permitted by making the payment in the form of Court fee stamp by the applicant. The Electoral Roll data for current year and for previous years (1980 onwards) is available at the office of Chief Electoral Officer, Kashmere Gate. As per the existing arrangement, the facility of issue of Certificate of entry and inspection of entry for the Electoral Roll data prior to year 1994 is available at CEO office only. However, the facility of issuing certificate of entry and inspection of entry from the year 1994 onwards is available at the office of concerned Electoral Registration Officer.

FEE

1. Inspection Fee of Electoral Roll : Rs.5/- per hour or part there of ;

2. (i) Extract of electoral rolls of current year : Rs. 2/- per entry/per head in the Same premises

(ii) Additional entry in the same premises : Rs.1/- per entry

3. (i) Extract of electoral roll of previous year : Rs. 3/- per entry/per head in the same premises for one Revision year.

(ii) Additional entry in the same premises : Rs. 1/- per entry**

** A sum of Rs. 1.00 extra for each roll year prior to current year roll, will be charged for extract.

Urgency Charges: Double the rates of the normal will be charged if the certificate is required earlier than 04 days period.

4. Electoral Roll Data for the Current Year in Hindi & English is also available in the form of CDs at the cost of **Rs. 100/- per CD** for Assembly Constituency.

(iii) CONDUCT OF ELECTIONS TO ASSEMBLY CONSTITUENCIES AND PARLIAMENTARY CONSTITUENCIES IN NCT OF DELHI

There are seventy Assembly Constituencies and seven Parliamentary Constituencies in NCT of Delhi. For every Constituency, for every election to fill a seat or seats of Delhi Legislative Assembly or Parliament, the Election Commission designate or nominate a Returning Officer (who shall be an officer of Government or of local authority) in consultation with Govt. of NCT of Delhi. The Election Commission may appoint one or more persons, officer of government or of a local authority to assist any Returning Officer in the performance of his functions. It shall be the general duty of the Returning officer at any election to do all such acts and things as may be necessary for effectually conducting the election in the manner provided by the Act and rules or orders made there under.

(iv) Who can stand for Election to Assembly or a Parliamentary Constituency?

Any Indian citizen who is registered as a voter and is over 25 years of age is allowed to contest elections to the Lok Sabha or State Legislative Assemblies. For the Rajya Sabha the age limit is 30 years. Every candidate has to make a deposit of Rs. 25,000/- for Lok Sabha election and Rs. 10,000/- for Rajya Sabha or Vidhan Sabha elections, except for candidates from the Scheduled Castes and Scheduled Tribes who pay half of these amounts. The deposit is returned if the candidate receives more than one-sixth of the total number of valid votes polled in the constituency. Nominations must be supported at least by one registered elector of the constituency, in the case of a candidate sponsored by a registered Party and by ten registered electors from the constituency in the case of other candidates. Returning Officers, appointed by the Election Commission, are put in charge to receive nominations of candidates in each constituency, and oversee the formalities of the election.

(v) Broad outlines of duties of a Returning Officer:

- (1) Drawing up, well in advance, a programme and plan of detailed arrangements for the poll.
- (2) Procurement of voting machines and all election materials in sufficient quantity.
- (3) Issue of public notice of election in Form 1 of the Conduct of Elections Rules, 1961 on the day on which the notification calling the election is issued.
- (4) Reception of nomination papers, security deposits, etc.
- (5) Administering oath or affirmation to candidates after they have filed their nomination papers.
- (6) Dissemination of information contained in the affidavits filed by the candidates.
- (7) Scrutiny of nomination paper.
- (8) Recording of reasons in brief for rejecting any nomination paper.
- (9) Receipt of notices for withdrawal of candidatures.
- (10) Allotment of symbols to contesting candidates.
- (11) Preparation and publication of notice of nominations, list of validly nominated candidates and list of contesting candidates.
- (12) Assessing the requirements of (i) ballot papers for use in the balloting units of the voting machines
(ii) Postal ballot papers for service voters and voters on election duty, etc and

- (iii) Tendered ballot papers and arranging the printing and supply thereof;
- (13) Preparing the lists of classified service voters who have appointed proxy voters;
- (14) Establishing contact with the contesting candidates and political parties to ensure free, fair and smooth election;
- (15) Convening of meeting of the constituency committee to discuss common problems relating to conduct of election , review of law order situation , enforcement of code of conduct for political parties, etc;
- (16) Preparation and commissioning of voting machines about one week in advance before the date of poll
- (17) Transport arrangements for the polling parties, voting machines and election materials
- (18) Dispatch of polling parties for the conduct of poll and supply of voting machines, tendered ballot papers and other election materials to them;
- (19) Effective supervision of the poll
- (20) Appointment of counting staff
- (21) Transport and storage of voting machines after and poll, under strict security arrangements
- (22) Fixing of date, time and place of counting and actual counting of votes
- (23) Declaration of result
- (24) Transmission of all voting machines, election papers and election materials after declaration of results, to the District Election Officer for safe custody
- (25) overall supervision of election work

(vi) Some of the important arrangements for the conduct of election also to be made by the District Election Officers include:

- (1) Selection (and , at the appropriate time, setting up) of polling stations, with the previous approval of the Election Commission
- (2) Formation of polling parties and appointment of Presiding Officer and Polling officers for each polling station;
- (3) Imparting intensive training to the polling personnel(including those on reserve duty)
- (4) Building awareness about the use and working of Electronic Voting machine among the general public , political parties, candidates, and media
- (5) Printing of postal ballot papers for service voters and their dispatch to the service voters
- (6) Scrutiny of accounts of election expenses of contesting candidates and submission of returns to the Commission
- (7) Safe custody of all voting machines, election papers and election materials after the completion of election and during the period specified for the purpose.
